#### **Monthly Operations:**

The month of September has been relatively quiet. The Fire Department is currently testing out a new Chevrolet Silverado EV Truck for the next three weeks. Safer Oceans Systems seems happy with the old Fire Hall and has already completed their first training session. This month, we had 1 major vehicle fire that could have become structural. As we head into winter we are starting to prepare for Wildland fire training.

#### **Upcoming Expenses:**

We are currently looking into improving the Burn Building for the Fire Department and membership. Last month we finished a grant application in hopes to get propane in there. This month we are looking at making structural improvements. For example, creating the burn building into a mock ship and a two-story structure. As a result, we need to buy metal and other materials. We are estimating that it will cost roughly \$7,000 dollars. I would like to ask the Trustees if they can make a motion that the rent income, we get from Safer Oceans Systems go towards improving the burn building to the amount of \$10,000 dollars or the next 5 months of rent.

### GABRIOLA FIRE PROTECTION IMPROVEMENT DISRTRICT BYLAW NO. 107

A bylaw for levying taxes on the land and improvements within the Gabriola Fire Protection Improvement District for fire protection purposes.

The Trustees of the Gabriola Fire Protection Improvement District in an open meeting assembled, ENACT AS FOLLOWS:

- 1. The sum of one million, four hundred, six thousand, and twenty-three (\$1,406,023) dollars is required by the Improvement District for fire protection purposes in the year 2025.
- 2. A tax at a rate determined to be necessary to raise the aforesaid sum is hereby levied for the year 2025 on all land and improvements as defined in the School Act, within the Improvement District in accordance with section 711 of the Local Government Act.
- 3. The said taxes shall be due and payable as provided in the Taxation (Rural Area) Act and if delinquent shall bear interest at the rate set out under the Taxation (Rural Area) Act until paid or recovered.
- 4. This bylaw may be cited as the "Fire Protection Taxation Bylaw 2025".

INTRODUCED and given first reading by the Trustees on the 2<sup>nd</sup> day of October 2024.

SECOND READING given by the Trustees on the 2<sup>nd</sup> day of October 2024.

RECONSIDERED and finally passed by the Trustees on the 2<sup>nd</sup> day of October 2024.
