Chairperson Paul thanks Jessie Longo for being Corporate Officer. She has greatly improved the GVFD and GFPID.

Chairperson Paul welcomes new Corporate Officer, Matt Dow.

Fire Chief Report AGM 2024

Hello,

I would like to ask everyone to please take a moment to remember our fallen firefighters. Tom Upton passed in a training session in Comox April 8, 2006, and Jay Dearman was tragically struck by a vehicle while jogging January 24, 2018.

Gabriola was successful on a UMBC community emergency preparedness fund grant of \$30,000 to purchase four new self-contained breathing apparatus. The department now has 22 units giving every firefighter in the hot zone and a SCBA unit.

Gabriola did two wildfire deployments last summer one to Fort St. Johns and a second to Adams Lake near Kamloops. Wildfire deployment provides broad experience and training, revenue to support equipment upgrade. after expenses, Gabriola brought back \$71,000.

The Gabriola fire department has one of the first collaboration agreements in BC with BCEHS to practice to Emergency Medical Responder scope. This means better patient care through more in depth vitals can be done and pain management if waiting for BCEHS.

The fourth year of the day firefighter program is to:

- provide a 90 second response time
- keep building and maintaining apparatus

The RDN will be applying for a Firesmart grant and the Gabriola fire department will have its own Firesmart coordinator for electoral area B. The plans include:

- Fuel management and looking into chipping with a collaboration of GALLT, an Islands trust representative and Gabriola futures
- We will be attending the farmers market distributing FireSmart material

Gabriola's leaders from the Fire Department, RCMP, BCEHS and Doctors are meeting to collaborate about emergency response. The first objective is to improve communication. we now have a repeater frequency with radios available for fire ambulance RCMP, and the doctors. In the fall, we ran a mass casualty incident involving all the Emergency response to agencies on Gabriola and put the communication to the test. Was a successful training day with good communication.

Membership is 36 members strong. We are full at 40 members; we are currently doing an intake for Hall #2 with the hopes to bring new members on end of May.

Gabriola Fire will be hosting the Fire smart open house May 11 10-2 family fun events showcasing all the emergency response agencies as well as a fire smart tradeshow this coincides with emergency preparedness week.

on April 6, Gabriola fire department was successful on the retest for the superior tanker accreditation. We did the commercial at 400 gallons for one hour and was rewarded the qualification for residential rate as well. Gabriola Fire Department maintains the highest rating for a volunteer department Dwelling Protection Grade of 3C from the Fire Underwrites.
